OPTION #1 ---- **PAY CIVIL PENALTY (Points Assessed)**

I understand payment of the fine amount waives my right to elect a driving course or request a court hearing.

PROOF OF A VALID DRIVER LICENSE, VEHICLE REGISTRATION OR INSURANCE CARD MUST BE SUBMITTED WITHIN THIRTY (30) DAYS AND ACCOMPANIED BY A \$7.50 DISMISSAL FEE.

OPTION #2 ---- **PLEAD NOT GUILTY**

Mail or bring your written request to plead not guilty and appear in court to the Clerk's Office. You will be advised by mail of your scheduled court date. Be sure your name is clear and a current address is given. The court may impose a fine not to exceed \$500.00 or require attendance at a Driver Improvement School – or both.

OPTION #3 ---- **ELECT DRIVING COURSE (No Points Assessed)**

I have read and understand the terms of this option as outlined in attached Election information. Complete Affidavit, signed and notarized, and return in the enclosed envelope with the following fine amount.

WARNING: Failure to exercise one of the options shown to satisfy your traffic violation will result in the suspension of your driver license, an additional assessment of \$18.00 and a \$47.50 license reinstatement fee. If electing to attend school and you fail to complete, your driver license will be suspended, additional fees and the balance of the original fine amount will be due.

THE CLERK MUST RECEIVE YOUR COMPLIANCE WITH ONE OF THE OPTIONS WITHIN 30 CALENDAR DAYS OF THE DATE THE CITATION WAS ISSUED.
